LPSO Officer Report:

-Resident raised concern over hypodermic needle found near lake in common area. Wanted to share the proper procedure for disposal, which is to call the LPSO to have them remove and dispose of properly.

-Resident asked if we need "Camera Usage Signs" in areas with cameras. Board doesn't believe so but will look into.

-Sheriff's Office number to call 225-686-2241, can also google Livingston Parish Sheriff's Office for the number if needed it's just the main office number. Obviously 911 in emergency situations. -LPSO Deputy said that we should be able to be provided reports for citations given during neighborhood patrol hours. They have been requested by the board. He said he would email Trevor and let him know we were asking. They will be shared as soon as they're gotten.

Speed Humps on Melrose:

-Why does HOA have to pay for cost of street sign replacing? We have decorative street signs specially installed by the HOA so we are responsible for their replacement and repair. -It was mentioned the there are some signs that don't have decorative ones, Shane said he would check it out. If you know of any street signs that are missing or damaged please notify the HOA.

Collections:

-Resident asked if we can contact mortgage companies about unpaid HOA fees. The answer was no, per Shane.

-Many questions came up on the magnitude of past due collections. The board recognizes this as an immediate issue. Liens have been being used but are proving not very effective. The board is taking steps to begin filing "Personal Judgements" against homeowners with unpaid dues. Neighborhood Concerns:

-Meeting date. It was determined by an overwhelming majority hand raise to propose an Amendment to the By-Laws to change the annual meeting date for official vote by the members. Date decided on was first Saturday of March, unless it is Mardi Gras or Easter weekend in which case the meeting would be the following Saturday. Information on when this vote will happen will be released when it is available.

-Date dues are paid change? By a raise of hands 17-9 in favor of not pursuing change at this time. Dues will remain to be paid on January 1

-Rental Properties. We cannot stop people from renting their homes. It was proposed that we vote on charging rental properties a higher amount for dues but attendees agreed the board should further research higher dues for rental properties.

-Chickens. Some residents have asked that we discuss voting on allowing chickens. It was an overwhelming majority that did not raise hands in support of this. Of the 44 residents present only one raised a hand in support of this. HOA bylaw stands, chickens are not permitted to be kept in this neighborhood.
